Notice of Race:

Commodore's Cup Regatta

October 15, 2011

1. RULES

- 1.1. The series will be governed by the rules as defined in The Racing Rules of Sailing 2009-2012 (RRS) and US SAILING Prescriptions.
- 1.2. The WSCYC Standard Sailing Instructions for Sinclair Inlet (effective 1/01/2011) (SI) will apply.
- 1.3. The PHRF-Northwest handicapping rules will apply.
- 1.4. Racing rule A1 will be changed to count all races. No races are excluded in the scoring.
- 1.5. The Racing Rules of Sailing rules 35, A4.2, and A9 will be changed. The changes will appear in full in the Sailing Instructions or the Notice of Race NOR). The sailing instructions may also change other racing rules.

2. ELIGIBILITY AND ENTRY

- 2.1. The regatta is open to all WSCYC skippers with PHRF ratable boats. Racers who do not know their boats rating are requested to contact the WSCYC Vice Commodore before race day. This will allow time for assignment of an "off the cuff" rating that (we hope) will be fair to you as well as the other participants. In the event of disagreement over a rating, the decision of the Race Committee shall be final.
- 2.2. Eligible boats may enter by completing the form provided below.
- 2.3. Late entries will be accepted at the discretion of the Race Committee.

3. CLASSIFICATION

- 3.1. There is only one class, Class 1, which is denoted by the signal flag number 1 (white with red dot). This changes SI Rule 5.2.

4. FEES

- 4.1. Entry fee is \$15.00, or if a PHRF-NW member, \$10.00, for the entire series, no matter how many races are raced.

5. SCHEDULE

- 5.1. Registration: Saturday, October 15, 2011, from 8:30 to 9:30 a.m.
- 5.2. Date of racing: Saturday, October 15, 2011.
- 5.3. There will be one class and one start for each race of the regatta.
- 5.4. Number of races: Three (3).
- 5.5. The scheduled time of the first warning signal for the race is 10:00 a.m. The warning signal for the race following shall be at least 10 minutes after the last boat finishes or the expiration of the time limit.

6. MEASUREMENTS

- 6.1. Each boat shall have a valid PHRF-NW rating certificate or shall obtain an "off the cuff" rating as described in NOR rule 2.1.

7. SAILING INSTRUCTIONS

- 7.1. The Sailing Instructions are available at wscyc.net in PDF format as “WSCYC Standard Sailing Instructions for Sinclair Inlet (SI).

8. VENUE

- 8.1. The race will be held in Sinclair inlet and Port Orchard. The start is adjacent to the Port Orchard Marina breakwater.
- 8.2. The SI shows the location of the racing areas.

9. THE COURSES

- 9.1. The courses are given in the SI.

10. SCORING

- 10.1. There are no excluded races.
- 10.2. One race is required to be competed to constitute the series.

11. TIME LIMIT

- 11.1. The time limit for the first boat to finish will be 2 hours for each race. Boats failing to finish within 2 ½ hours will be scored Did Not Finish (DNF) without a hearing. This changes RRS Rule 35.

12. ALLOWED RADIO COMMUNICATION

- 12.1. A boat may contact Navy, commercial or private traffic to confirm that they are not going to interfere with that traffic in the foreseeable future. Such communications may only be used to ascertain what action the traffic would like the boat to accomplish. Use channels 13, 14 and 16 as appropriate.

13. PRIZES

- 13.1. The winner of the regatta will be awarded the Commodore’s Cup perpetual trophy to hold for the year. In addition, prizes will be awarded up to the third place for each division, based on the number of entries. The number of prizes is determined by dividing the number of entries by 2 and rounding down. For example, if there are 5 entries in a division, there will be prizes for first and second place.

14. DISCLAIMER OF LIABILITY

- 14.1. Competitors participate in the race entirely at their own risk. See RRS Rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the race.

15. INSURANCE

- 15.1. Each participating boat shall be insured with valid third-party liability insurance.
